BAXTER INCREASES DIVIDEND AND DECLARES QUARTERLY DIVIDEND

DEERFIELD, III., May 5, 2020 – Baxter International Inc. (NYSE:BAX), a leading global medical products company, today announced an increase in the company's quarterly cash dividend to a rate of \$0.245 per share of common stock. This represents an approximately 11% increase over the previous quarterly dividend rate of \$0.22 per share. Baxter's Board of Directors declared the dividend payable on July 1, 2020, to stockholders of record as of June 5, 2020. The indicated annual dividend rate is now \$0.98 per share of common stock.

"Baxter's disciplined capital allocation strategy is focused on driving innovation and increased access for patients, growth for the business, and enhanced value for our investors," said José (Joe) E. Almeida, chairman and chief executive officer. "The company's ongoing transformation has strengthened our financial position and allowed us to annually increase our quarterly dividend rate for the fifth straight year."
